Get the Facts and Be Informed by James Macon, President

Members, if you have any questions or concerns about the union or company please come to monthly union meetings, contact your steward or call the union office at 414-342-4300,. Avoid being miss-informed by others and get the facts first-hand.

During Summerfest, there were concerns about how matters were handled or should have been handled pertaining to overtime work assignment. Although there were members who may have been displeased of not receiving overtime, the opportunity was given to anyone who wanted the work. Unfortunately, some members did not accept the overtime work offered to them. The decision on how the overtime work was given, resulted from the authority of our local, and as president of ATU Local 998, I stand behind that decision.

The local's stewards, top officers, and I meet on a regular basis, to discuss the best interest of our local. Monthly union meetings are also set in place for a time of membership discussions, concerns and questions to be addressed. There is no reason for any member to be misinformed by others on the happenings of our local, or concerns about company matters.

Other concerns, such as the summer pick was huge because we are short of drivers. In the last few months before the summer, 31 buses did not go out and 15 went out late. On top of all of that, Summerfest and Baseball had to be serviced by our Bus Operators, including regular bus service. With all that being said, "Where were we going to get the drivers?" A decision was made by the Executive Board to open the doors for others to get overtime. When I say others, that means, everyone in the company, including, shops, garages, clerks, and AA's.

We (ATU Local 998) also included workers who did opportunity to work. Now keep in mind, Local 35 is responsible for the jobs that were given as overtime work. We were only helping them. The overtime work was not the job of ATU Local 998, only the job of Scheduling. Our local made it possible for everyone who wanted overtime

work to receive it. That has never happened in the history of this union or company. Therefore, if overtime work was offered to you, and you refused it for whatever reason, do not be dismayed.

Now, State Fair is here. AA's and Clerks have the opportunity to work overtime if they have never had a chance to do it in the past. It is my understanding that complaints from some of them were made about the work they were getting, again, lack of communication. The overtime work is actually the work of Local 35 being done through ATU as OVERTIME WORK.

The Union's communication with Dan Boehm has been great. Unfortunately, there seems to be a lack of communication with some workers among themselves at Hill-side that has resulted to lack of communication circulating on the outside. Apparently, there are too many leaders and not enough followers. It seems mutual agreements made by the company and union do not reach lower management at Hillside, leaving inaccurate information to fly everywhere. Right now, we are coming into a new pick for the next year. The union has no knowledge of what is taking place at this time. We are aware of a funding issue that caused the pick to spread out.

The local is working on other problems and unknown issues for the next pick that has been brought to our attention. Therefore, give us a chance to work on these things to avoid rumors.

The Executive Board and I are working on ways to get members involved in the Local. I am working on setting up classes with the ATU International to let members know what the process is in contract negotiations, because a lot of people do not know the process. Classes are being set up for our members to take advantage of learning how to reach out to the public. If we do not have the public on our side, we are going to lose the battle. I understand that there are feelings that the public is not always right. But we have a lot of drivers who do not understand how important the public is in our struggle. I want our members to know how politics control your livelihood when it comes to contracts or anything else. Take a look Act 10 (mentioned in this publication). That's why we tell people to vote in the best interest for your job, because this is your livelihood.

In closing, I apologize to the retirees, for the prolonged newsletter. Unfortunately, We had to update the membership mailing list for the newsletter that goes out to our retirees. The local has been absorbing the cost of high postage on returned mail, due to wrong or inaccurate information for the mailing of the newsletter.

Vice President's Report by Rick Bassler

There were a lot of issues and concerns that Mr. Macon and I had to deal with, concerning Summerfest. We had to make sure the cash fare buses were placed where they needed to be, and oversee the instructors' hours at the "Park and Ride" lots and the Route #7 Shuttle fares. We also wanted anyone who is a bus operator to drive a bus. We informed the company that we did not want the Max card people not to drive. Clerks and Administrative Assistants and everyone else that wanted overtime, received it. Yes, there were problems. Yes, some changes are needed for next year. We will discuss this matter with the company after the State Fair, so that it does not occur next year.

Mr. Macon and I also spoke with Brian Dranzik (Director of Transportation – Milwaukee County). He informed us that the county is moving forward on the process that would bring transit under the county. The county has to wait for approval from the FTA on some options on how to do that. A "Hybrid" proposal would include the Director, and Deputy Director of MTS being county employees, and possibly an extension of MTS's current contract. However, again, no decision has been made. Mr. Dranzik believes that things would not change much from the way things are now. We will be negotiating our contract with the current Director, Dan Boehm and whomever his Deputy Director will be.

Work-Related Injury:

When you incur a work-related injury, make sure your doctor states this on his or her reports to the company. The company sends you to an IME (Independent Medical Examiner), the report sent back to the Claims Department will most likely state that it is a prior existing injury and not work-related. At that point, you have the right to appeal the ruling. You can find your own

attorney or use our union's attorney Dan Schoshinski. They can be reached at (414) 271-8650. Attorneys charge a percentage only if you win the case. Our attorneys charge you a lesser percentage than other law firms do. If you call our attorneys, tell them that you are from ATU Local 998, and that we referred you to call.

If you are on the sick list, or file for Worker's Compensation, first and foremost, apply for FMLA (Family Medical Leave Act). You have the right under ADA to request an accommodation within your restrictions. If the company states they cannot accommodate you, file for unemployment (414-438-7700).

Family Medical Leave Act (FMLA)

Anyone applying for FMLA must call the designated number for FMLA (414-937-3232), the day you go sick. This in compliance with Statue 825:303c, "Complying with employer policy" which states, "When the need for leave is not foreseeable, an employee must comply with the employer's usual and customary notice and procedural requirements for requesting leave, absent usual circumstance.

If you are on the sick list, or file for Worker's Compensation, first and foremost, apply for FMLA (Family Medical Leave Act). You have the right under Ada o request and accommodation within your restrictions. If the Company6 states they cannot accommodate your, file for unemployment (438-7700).

Grievance Settlements: The last three months include: 5 first steps 12 second steps and 13 third steps. Included in the settlements were 8 discharges. There were 3 members discharged for attendance. One member was reinstated, and the discharge was rescinded and made whole. Another member was reinstated with a suspension and last chance agreement. Two members were discharged for misses, and were reinstated with a suspension and last chance agreement. Two members were discharged for failure to qualify during their probationary period. They were both reinstated with a suspension and last chance agreement. One member was discharged for accidents and was reinstated with a suspension and a last chance agreement.

There was one grievance from Waukesha that was voted for arbitration. The grievance was resolved the day of the arbitration with a settlement that allowed the individual to resign with benefits.

I've been working on the pension reports across America and I have 438 pages of pension information that I am summarizing for my 998 Newsletter article(s). The percentages that different states are taking from retirees and active workers is just another way to **TAX** us more. Watch out for the Politicians; this is where they take advantage in saying that they will not "**RAISE YOUR TAXES**".

The state is responsible for the cleanup and tearing down properties and sending the bills to the owners (so we thought). When do others have the joy of buying properties and not having to pay for the abandoned properties? I will complete my report and start segments of it. I have been asked about the Milwaukee Transport Services Pension Plan for the retired and active workers. I will get more clarity on that also. Until the next ATU Local 998 Newsletter, the next holiday that comes up is "July 4th". Happy July 4th to you all.

The ATU Local 998 Women's Caucus is still thriving, and looking for new members. Come to the next meeting June 12, 2014 at 5:30 p.m.

Remember to watch your "ATTENDANCE" and your "FAMILY MEDICAL LEAVE ACT (FMLA) needs. Being in violation of your attendance will put you in "DISCIPLINE" status. Protect your Commercial Driver's License (CDL) and your Public Passenger Vehicle License (PPVL).

ATU Local 998 members, don't forget to fill out your application for Family Medical Leave Act (

(FMLA). If you are sick, or going to have surgery soon, call your department/station Supervisor and let him/her know, then ask to be transferred, or you can call the company at (414) 937-3232 and request FMLA yourself. You can use FMLA for a serious injury or illness for yourself, spouse, your child, your stepchild, foster child, or a child in your legal custody. When the company is closed, or you do not get an answer, leave a message on the voice mail and follow up ASAP during business hours. Once you have the FMLA forms, get them to your doctor ASAP and stay in touch with your doctor's office to make sure your forms are being filled out in a timely manner. You have fifteen (15) consecutive days to get your FMLA forms back to the company. If this is not possible, you may have to call the nurse (Debbie) at the company and speak with her about getting an extension. See Vice President Rick Bassler, President James Macon, the writer of this article, or fax (414-342-1998) in your FMLA forms so they can be reviewed for corrections before taking them to the company. Make sure to fax your "Application for Family Medical Leave Act (FMLA)" to, (414) 344-2876 before your 15 consecutive days are up. To be eligible for FMLA you must have worked one (1) year before applying and have the required State and/ or Federal hours accumulated.

Family Medical Leave Act (FMLA) has its benefits such as preventing your attendance record from falling into a "DISCIPLINE" status and helps you to exhale.

When you are down five (5) minutes or more, call the dispatcher to report your down time. The driver is the first person the riding public sees. Please, keep the driver's area clean for yourself and for the next driver relieving you on the road. Remember to report all incidents and accidents to the dispatcher and fill out your TR62's.

Remember to close the shield on your bus; use your seatbelt; stay off the cell phones and other portable devices while driving.

A few months ago, I was asked to be Interim Chief Seward of Shops until a new steward was voted into office. I gladly accepted the position. At that time, I was asked to write an article for the 998 Express Newsletter. I had nothing much to write about. In the past, I only submitted an article when I needed to vent. Now that the elections are over, I have some concerns of how things were handled.

In the last couple of weeks of the elections, it was rumored that management of Kinnickinnic Transportation approached a Financial Secretary candidate and asked him to put out a luncheon in celebration of construction at KK Station and the start of pot hole repair season. I was told that the Financial Secretary candidate supplies luncheons very often, so this was not uncommon for him to do so. This is in response to your letter dated April 23, 2014, regarding Local 998 Member about recent campaigning by certain candidates running for office in the upcoming election of local union officers.

This office will issue a formal opinion on an issue arising in an election only after a local union's membership has rendered a final determination on an election challenge and the challenge has been properly appealed to the International Union. As these issues are currently being handled by Local 998, it is premature for this office to formally interject itself at this time.

With that said, it appears that under the present circumstances, there is no violation of the ATU Constitution and General Laws (CGL), Local 998's Bylaws or applicable law. As reported two candidates campaigning for office have brought food onto Local 998 properties for members. There is no indication that the food was purchased with funds from either the local union or an employer. In fact, noted that one of the candidates "made the food in his kitchen" and that the other "purchased" food.

There is no indication that any employer extended courtesies to these candidates that were not extended to all candidates with regard to setting out food. There is no allegation that the receipt of any food was conditioned on members voting for certain candidates. In fact, in one case, reports that the food was ostensibly for the purpose of celebrating the end of construction and beginning of "pothole repair" season. Lastly it does not appear that the value of the food received by any one member was anything other than *de minimis*. Based on those facts,

ACT 10 RULING

On July 31st, The Wisconsin Supreme Court upheld Scott Walker's legislation (three months before he seeks re-election) that states that public workers in Wisconsin do not have a constitutional right to collectively bargain. In a 5-2 decision, (Justices Michael Gableman, David Prosser, Patience Roggensack, Annette Zieglar, and N. Patrick Crooks voted to uphold Act 10, while Justice Ann Walsh

Bradley and Chief Justice Shirley Abrahamson dissenting) the Court ruled that collective bargaining over a contract with an employer is not a fundamental right under the constitution. It is a benefit that can be restricted or extended as an employer sees fit.

However, Justice Crooks, while agreeing with the majority, stated that while he believes that the law is constitutional, individuals should have the right to organize and bargain collectively, long a part of Wisconsin's progressive heritage.

"As thoughtful people from across the political spectrum and around the world have long recognized, collective bargaining benefits workers, employers, and society itself. Although Act 10 does not violate either the U.S. constitution or the Wisconsin constitution, it erodes longstanding benefits to both public workers and public employers."

Mary Burke, Walker's likely opponent in the November election, said she supports the right of workers to bargain collectively, but said that while worker concessions in contributions to pensions and health care were fair, the unions should have been bargained with.

Scott Walker states that Act 10 has saved taxpayers \$3 billion dollars, but fails to show concrete proof. The only concrete proof of Act 10 is the weakening of public employee unions, and the potential for Act 10 to infiltrate the private unions.

Although Act 10 does not affect us now (we are federally protected), it could start to affect local police and fire unions, and with enough Republican support, could change federal legislation.

This may not be the end of this story. The County Executive of Dane County, Joe Parisi, stated that his office will be consulting with labor attorneys to explore legal options.

Security Report by Herb Forbes

(Security Chairman and Assistant Steward – Fiebrantz Station

Hello again ATU Local 998 Brothers and Sisters. I am pleased to be able to address you again in this capacity. In my last Safety Meeting with Julie Schneider, union representatives James Macon (President) and Richard Olson (Chief Steward of Kinnickinnic Station) were both present. I would like to take this opportunity to thank both gentlemen for attending the meeting. They were able to attest the unwillingness of Ms. Schneider to work with the Union on the safety issues, and the suggested solutions we proposed. A huge concern that we are facing now at various work stations is "vandalism" to vehicles as well as theft of vehicles. I propose that G-4 set up sub-stations directly at each station and command post on site. By doing so, they are on-site at all times opposed to being out and about burning unnecessary fuel. Thus, saving on fuel cost for G-4 and enabling them to respond faster to issues at the station. I also informed Ms. Schnieder that I would be willing to get intel from the Marquette Security Systems on their direct access to police response.

Ms. Schneider seems to despise the fact that these ideals cannot be directly linked to her for personal accreditation, and as a result, refuses these solutions. This is done by simply replying, "Who will pay for this?"

On another note, there are drivers who are misshandling bus fare tickets, as well as handling monies that can't be accepted by the fare box. This action must stop. I am requesting you to properly rip the bus fare tickets in four's and dispose of them properly. Also, if a dollar-bill is rejected by the fare box machine, depress the "Accept as Dollar" amount. If that fails, offer the passenger a ride as the company has instructed you to do, and keep on moving. Fellow workers, anything beyond this will cause you undue stress, a trip to the supervisor's office, or worse. This could cause you to be assaulted over monies that you share no stock or profit shares in. This comes directly from upper management. Therefore, make the best of your employment with M.C.T.S. Continue to support your Local by getting involved, through attending monthly membership meetings, where you can voice your opinion, ask questions and share your concerns. Stay safe.

Pensioners' Dues Increase

Pensioners who are paying \$5.00 monthly dues will have a dues increase in the amount of 6.00 per month. (\$4.00 will be applied to ATU International and \$2.00 will be applied to ATU Local 998).

According to Section 21: (DUES) "The monthly dues for members listed on the pensioners' list will consist of an amount equal to \$2.00 more than the minimum monthly dues required by the International Union."
